カナダに入国する18歳未満の渡航者は未成年者として審査され、カナダ移民・難民保護法（Immigration and Refugee Protection Act）により、保護の対象となり、単独または片方の親同行・親以外の成人同行の場合、綿密な審査が行われます。

未成年者が入国時、書類の提示を求められ、適切な書類を所持していなかった場合、入国審査官により入国審査に時間がかかったり、入国可否が判断される可能性がありますのでご注意ください。
